TOWN AND COUNTRY PLANNING ACT 1990

TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) (ENGLAND) ORDER 2015 ("GPDO 2015")

DIRECTION WITHOUT IMMEDIATE EFFECT MADE UNDER ARTICLE 4(1) OF THE GPDO 2015

WHEREAS the South Downs National Park Authority ("the Authority"), being the appropriate local planning authority within the meaning of Article 4(5) of the GPDO 2015, is satisfied that it is expedient that development of the description set out in Schedule 1 below, should not be carried out on the land described in Schedule 2 and shown edged red on the attached maps, unless planning permission is granted on an application made under Part III of the Town and Country Planning Act 1990.

NOW THEREFORE the said Authority in pursuance of the power conferred on them by Article 4(1) of the GPDO 2015, hereby direct that the permission granted by Article 3 of the GPDO shall not apply to development on the said land of the description set out in Schedule 1 below.

 its curtilage from a use falling within Class B1(a) (offices) of the Schedule to
 the Town and Country Planning (Use Classes) Order 1987 (as amended), to a

 - Being development comprised within Class O of Part 3 of Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).
- Development consisting of a change of use of a building and any land within
 its curtilage from a use falling within Class B1(c) (light industrial) of the
 Schedule to the Town and Country Planning (Use Classes) Order 1987 (as
 amended) to a use falling within Class C3 (dwellinghouses) of that Schedule.

Being development comprised within Class PA of Part 3 of Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).






